DURING 2013, THE ORGANIZATION PROVIDED 704 "KNOW YOUR RIGHTS" LEGAL PRESENTATIONS TO 8,255 INDIVIDUALS, INCLUDING 3,064 UNACCOMPANIED IMMIGRANT CHILDREN. IT PROVIDED 122 SMALL PEER-TO-PEER WORKSHOPS TO 1,157 ADULTS ON TOPICS INCLUDING CANCELLATION OF REMOVAL FOR LAWFUL PERMANENT RESIDENTS, BOND, AND POLITICAL ASYLUM.

THE ORGANIZATION PROVIDED INDIVIDUAL CASE ASSESSMENT AND FOLLOW UP PRO SE ASSISTANCE TO 5,588 INDIVIDUALS WHO CANNOT AFFORD TO HIRE PRIVATE COUNSEL. IT PROVIDED FULL DIRECT REPRESENTATION TO 94 INDIVIDUALS AND REFERRED 79 CASES TO VOLUNTEER ATTORNEYS IN THE ARIZONA COMMUNITY AND 276 CASES TO PRO BONO MATCHING ORGANIZATIONS AROUND THE COUNTRY.

IF IT IS DETERMINED THAT AN EMPLOYEE HAS ENGAGED IN A VIOLATION OF THE POLICY, THE EMPLOYEE WILL BE DISCIPLINED, WHICH MAY INCLUDE TERMINATION.
